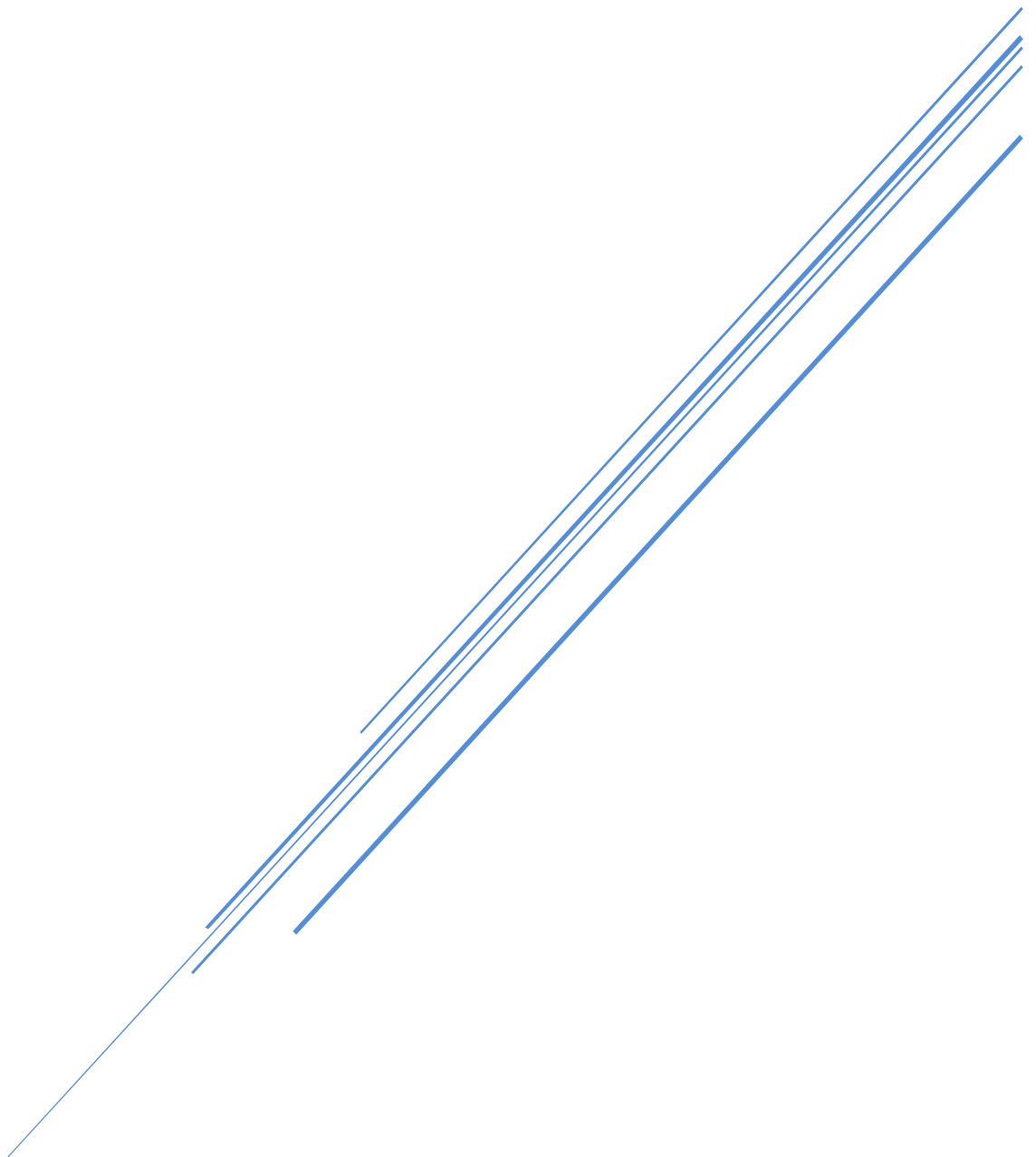

1. PROMOTION TITLE

3. PROMOTIONAL PERIOD

Start date: Tuesday 28th October 2025 @ 5:00pm ACDT

End date: Friday 12th December 2025 @ 11:59pm ACDT

4. ELIGIBLE ENTRANTS

Entry is open to Australian residents only.

Any entrants under 18 years of age must obtain the consent of a parent or guardian prior to submitting an entry. If the winner is under 18 years of age and does not hold a valid bank account, the prize will be awarded on their behalf to a parent or guardian.

5. ENTRY MECHANICS

5.1 How to enter

To enter the lottery, the entrant must complete the following steps during the promotional period:

- Purchase a lottery ticket ("qualifying transaction") from Kiai Training Centre Inc. web store ("participating venue").
- Visit <https://www.revolutionise.com.au/kiaitraining/shop/11403/> (or scan the QR code found on any officially branded posters); and fully complete and submit the online entry form with their personal details (full name, mobile number, email, and residential address).

Proof of purchase: The entrant must retain proof of purchase. The proof of purchase required is an original receipt for the qualifying transaction which will be emailed to the entrant upon successful payment.

5.2 Entries permitted

Entrants may enter multiple times provided that each entry is submitted separately in accordance with the entry requirements above.

For clarity, entrants must fully complete the online entry form every time they enter the promotion.

6. PRIZE POOL

The total prize pool is AUD \$6,500.00

7. PRIZES

7.1 Major Prize

The 1st draw (Major Prize) will be an electronic funds transfer (EFT) to the value of AUD \$5,000.00

7.2 Minor Prize #1

The 2nd draw (Minor Prize #1) will be an electronic funds transfer (EFT) to the value of AUD \$1,000.00

7.3 Minor Prize #2

The 3rd draw (Minor Prize #2) will be an electronic funds transfer (EFT) to the value of AUD \$500.00

8. EQUAL CHANCE

The major prize will be drawn first, followed by minor prize #1, and then minor prize #2. This will ensure that all entrants have an equal chance of winning the major prize.

9. DRAW

The prize draw will be determined using the individual ticket receipt numbers, issued upon successful payment, and a random number generator.

The draw of all prizes will take place on Saturday 13th December 2025 @10:00am ACDT at Kiai JuJutsu Kan (Seacliff Recreation Centre – 28 Yacca Road, Seacliff, SA, 5049).

10. NOTIFICATION

Winners will be notified by email within seven (7) days of the draw date.

11. CLAIMING PRIZES

Winners have two (2) months from the draw date to claim the prize by responding to the email notification. Where a winner does not claim the prize within the two (2) months, the prize will be foregone.

After a winner has claimed their prize, it will be transferred to their nominated financial institution within one (1) month of the date the winner claimed the prize.

12. PUBLICATION OF WINNERS

The last name and initial of the first name of each winner will be published at <https://www.facebook.com/KiaiJuJitsu> and <https://www.kiai.com.au> within thirty (30) days of the draw date.

13. UNCLAIMED PRIZE DRAW

Prizes must be claimed by Friday 13th February 2026 at 11:59pm ACDT. In the event of an unclaimed prize, the prize will be redrawn on Saturday 14th February 2026 at the same time and location of the original draw.

14. CANCELLATION CLAUSE

If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure, or any other cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify, or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.

15. PRIVACY
